## ORDINANCE NO. 3005-06

## AN ORDINANCE REZONING VARIOUS TRACTS OF LAND IN THE CITY OF CLINTON, ARKANSAS, FROM R-2 TO R-1 AND VARIOUS OTHER TRACTS FROM R-1 TO R-2 AND FOR OTHER PURPOSES.

WHEREAS, various individuals own tracts of land within the city limits of the City of Clinton, Arkansas; and

WHEREAS, said tracts of land are currently zoned either R-1 or R-2; and WHEREAS, the owners of said tracts have requested that their properties be rezoned and have sought rezoning of the tracts either from R-2 to R-1 or from R-1 to R-2 and have filed the proper applications with the City; and

WHEREAS, the Planning Commission has conducted a public hearing on the rezoning requests as required by ordinance; and

WHEREAS, as a result of the hearings, the Planning Commission recommends that said tracts be rezoned as either R-1 or R-2 as denoted below to accurately reflect their true use and the intent of the land use plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLINTON, ARKANSAS:

## Section 1:

The following tracts of land located in the City of Clinton, Arkansas, are hereby rezoned from R-2 to R-1 to wit:

1. ALL OF SOUTHEAST QUARTER OF THE NORTHWEST QUARTER (SEI/4 NWI/4), SECTION TEN (10) TOWNSHIP ELEVEN (11) NORTH, RANGE FOURTEEN (14) WEST LAYING NORTH OF THE ARCHEY FORK OF THE LITTLE RED RIVER.

2. ALL OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER (SW1/4 NE1/4), SECTION TEN (10) TOWNSHIP ELEVEN (11) NORTH, RANGE

PART OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER (SW1/4 NE1/4), SOUTH OF THE ARCHEY'S FORK OF THE LITTLE RED RIVER, AND PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER (NW1/4 SE1/4), ALL IN SECTION TEN (10) TOWNSHIP ELEVEN (11) NORTH, RANGE FOURTEEN (14) WEST, EXCLUDING THE FOLLOWING COWSERT PROPERTY: DESCRIBED AS BEGINNING AT A POINT 217 FEET NORTH AND 347 FEET WEST OF THE SOUTHEAST CORNER OF THE NW1/4 SE1/4 OF SAID SECTION 10, FROM WHICH POINT RUN N 07°00' W 245.0 FEET; THENCE, N 75°00' E 161.0 FEET. THENCE N 15°00' W 1000.0 FEET, THENCE EAST 335 FEET TO ARCHEY'S FORK OF LITTLE RED RIVER; THENCE IN A SOUTHEASTERLY DIRECTION WITH THE MEANDERING OF SAID RIVER 1300 FEET, MORE OR LESS, TO THE NORTH SIDE OF "OLD" RIGHT OF WAY OF U.S. HIGHWAY 65; THENCE WEST 58 FEET TO THE POINT OF BEGINNING.
