ORDINANCE NO. 2005-24

AN ORDINANCE CONFIRMING THE REZONING OF A TRACT OF LAND IN THE CITY OF CLINTON, ARKANSAS, FROM R-1 RESIDENTIAL TO HC HIGHWAY COMMERCIAL AND FOR OTHER PURPOSES.

WHEREAS, the owner of the property described herein has petitioned the City of Clinton to rezone said property from R-1 Residential to HC Highway Commercial; and WHEREAS, the Petition to rezone said tract of land has been presented to the

Clinton Zoning Commission which has recommended its approval; and

WHEREAS, the City Council of the City of Clinton finds that such a rezoning request is appropriate and should be granted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLINTON, ARKANSAS:
