## ORDINANCE NUMBER 119

AN ORDINANCE ACCEPTING A 75 ACRE TRACT OF LAND AS A PART OF THE CITY OF CLINTON, ARKANSAS.

WHEREAS, the County Court of Van Buren County, State of Arkansas, did on the 9th day of May, 1980, hear the petition of Jim S. Gowen and others for the annexation of a 75 acre tract of land to the City of Clinton, Arkansas; and, on that date did enter an Order for Annexation of said tract; more accurately described below, to be organized and incorporated under the name of Clinton, Arkansas:

Part of the W½ SE¼, part of the NE¼ SW¼ and part of the SE¼ NW¼, Section 26, Township 11 North, Range 14 West, described as beginning at the Northeast corner of the NW¼ SE¼ and run thence South 2100 feet or to the Northerly right of way of State Highway 95, thence Northwesterly along and with the Northerly right of way of State Highway 95 a distance of 2500 feet or to the intersection of the centerline of U. S. Highway 65, thence Northerly along the centerline of U. S. Highway 65, a distance of 800 feet or to a point 501 feet North of the South line of the SE¼ NW¼, the present City Limits of Clinton, Arkansas, thence East 500 feet to a point, thence Southerly along a line 500 feet East of and Parrallel to the centerline of U. S. Highway 65 for 501 feet or to the South line of the SE¼ NW¼, thence East 1980 feet or to the point of beginning, containing 75 acres, more or less.

BE IT THEREFORE ORDERED AND ORDAINED that the foregoing described tract of land is incorporated into and made a part of the City of Clinton, Arkansas.
